

What is Electronic Visit Verification?

The EVV (Electronic Visit Verification) process in home care provider industry is used to track and verify caregiver visits to patient's home using technology.

It ensures that caregivers enter clock-in, clock-out and charting services information correctly to promote transparency, accuracy and accountability while improving quality of care.

The 21st Century Cures Act, signed into law in December 2016, includes provisions related to Electronic Visit Verification (EVV) for personal care and home health services funded through Medicaid. While the federal government has set some EVV standards, there are variations in requirements at the state level. EVV process must capture atleast 3 key components including client identification, caregiver identification and date/time stamp for clock-in and clock-out as per federal requirements. The statewise variations include data elements that must be captured during EVV, including additional details on services provided, caregiver qualifications, and more.



Why do You Need Electronic Visit Verification Automation?

Manual updates in Electronic Visit Verification (EVV) systems may be necessary in situations where caregivers forget to clock in or out, fail to mention provided services, encounter technical issues like geo location not working with their mobile phones, or face difficulties with the client's phone during the client visit, or they don't get opportunity to update shift details later. In this situation, back office operations staff at agency office then need to manually fix this issue. They need to consult caregiver and client to collect and verify information about the shift and then manually update that information in EMR system.

When EVV update process is done manually, there is additional time and investment from Home care agency and additional risk of manual errors.


EVV Update Bot Process Flow
